## DET NORSKE VERITAS CERTIFICATE OF COMPLIANCE

### Objective:

1. Select samples of OceanMaster Kruiser 3 Antifouling paint (Single component coating) for analysing on Tin content.
2. The samples selected are to be analyzed in the laboratory for verification of Tin content according to limit as specify in IMO MEPC49/22/Add.1 , ANNEX 9- Resolution MEPC.104(49), "Guidelines for Brief Sampling of Anti-Fouling Systems on Ships".

### Samples Selected and Test Results:

1. A total of four wet samples were selected as follows,
  - OceanMaster Kruiser #3 Self Polishing Antifouling Red, BATCH 1202040
  - OceanMaster Kruiser #3 Self Polishing Antifouling Black, BATCH 1204150
  - OceanMaster Kruiser #3 Self Polishing Antifouling Blue, BATCH 1202050
2. The analysis was performed by laboratory of TÜV SÜD PSB Pte Ltd, Singapore.
3. According to the definition of compliance as described in IMO MEPC49/22/Add.1 , ANNEX 9 - Resolution MEPC.1 04(49), "Guidelines for Brief Sampling of Anti-Fouling Systems on Ships", In practice organotin compounds should not be present above 2,500 mg organotin (measured as Sn) per kg of dry paint.
4. The result of the analysis shows that the Tin (measured as Sn) content in all four samples tested were less than 1 mg/kg.
